NHS Digital is the secure haven for NHS patient data, a single secure repository where data collected from all branches of the NHS is processed.

NHS Digital have the power under the Health and Social Care Act 2012 (section 259) to issue a [Data Provision Notice](#).

Recently a Data Provision Notice was issued for [Research and Planning](#). This Data Provision Notice is valid from 1<sup>st</sup> September 2021.

Complying with the Health and Social Care Act 2012.  And  Article 9(2)(g) "reasons for processing for substantial public interest'

<b>6) Rights to object</b>	You have the right to object to the data being transferred and in order to do this you should complete an <a href="#">opt out form</a> and send this to the <a href="#">Practice</a> .

<p><b>7) Right to access and correct</b></p>	<p>You have the right to access the data that is being shared and have any inaccuracies corrected. There is no right to have accurate medical records deleted except when ordered by a court of Law.</p>
<p><b>8) Retention period</b></p>	<p>The data will be retained for active use during the processing and thereafter according to NHS Policies and the law.</p>
